1. Minutes -

8. MEDIC FOR PNWIC

- Scott got a quote from the medic and it would be \$3500-4000. There is nothing in the budget for this. OHSET paid for it the last time we were in Redmond.
- Hospital is less than 10 minutes; we typically want a 10 minute or less response time.
 There is a fire/rescue at airport about 3 minutes away.
- Melanie made a motion we do not hire EMT's due to cost; Kayelee second

9. JOB ASSIGNMENTS
